We have been without one for some time now and we are constantly being asked for a copy, by our many visitors, so it seemed high time that we put the matter right. It was difficult to decide quite how to go about it - there was so much that was good about the last one but quite a lot that was outdated. In the end we decided to simply update the text of the last issue and replace a few of the pictures which, after all, were nearly 25 years old. A small committee undertook this task and now at last their efforts have reached fruition.

As I write the 'new' revised guide book has just arrived from the printers. It will be good to have copies in the Church ready for Easter and the visitors. Although it was the PCC who first set this project in motion the committee of FoStA has agreed to fund the preparatory work for the guide and pay for the first print run of 200 copies. The PCC will then, with sales revenue, be able to self-fund any subsequent reprints or changes that might be necessary in the future.

As many of you will remember, John Gimson was one of the original FoStA committee members who did a vast amount of work to get the Friends scheme up and running in 2008. Since that time he has acted as the webmaster and helped in all manner of ways particularly in support of 'Memsec'. He has now relinquished this task and passed on the baton but we can't let him go without saying how grateful we all are and to offer him a huge and sincere vote of thanks.

We are extraordinarily fortunate in finding someone to take John's place and FoStA has a new webmaster in David Goodwin who had a bit of an introduction in the last Spring edition of the newsletter. You will be able to read more about his undertakings and progress later in this issue. A warm welcome to you!

I have been given to understand that our webmaster is quite a 'wine buff' so we are very much hoping to organise a wine tasting dinner later in the year. All details in due course.

The former Stratton Vicarage in Diddies Road and the Rectory in Bude will be sold and the surplus proceeds arising from these sales will transfer to the Diocesan Pastoral Account.

It will also be of interest to many of you to know that from the third week after Easter, Fr David will also become the Priest in Charge of Kilkhampton with Morwenstow. The Revd Alison Hardy will be Curate there as well. Their Induction is arranged for Friday 29<sup>th</sup> April at Kilkhampton Church. It is hoped that a House for Duty Priest will be appointed there in due course.

So, as we go forward to the next few months with all the changes and challenges we shall surely face, do please remember us in your prayers as we will remember you.

## So, Where Does Your Money Go?

St Andrew's Church is a Grade 1 Listed building, with parts dating back to the 13<sup>th</sup> Century, and, like so many other churches in the Church of England, the burden of maintaining this historic building and its ancient graveyard has become increasingly heavy for our small congregation. This is where FoStA – Friends of St Andrew's – comes in. There are many people who for various reasons do not attend services at St Andrew's on a regular basis, but nonetheless have a link with St Andrew's or consider St Andrew's special. Joining FoStA enables you to maintain your connections with St Andrew's and to contribute towards the costs of preserving the building and churchyard for future generations.

The organisation of FoStA was established in September 2008 to operate as a sub-committee of the PCC. The resolution of the PCC states that the objects of FoStA are to *'advance the mission and ministry of the church in the community through helping to fund the repair, maintenance, restoration, preservation and development of St. Andrew's Church, and of the fixtures, fittings and ornaments in the Church and general care of the churchyard'*.

FoStA raises funds for St Andrew's in many ways. There are of course the annual subscriptions from the membership, which currently stands at 142. Regular social and fundraising events are organised which have included a Burns' Night supper, a murder mystery evening, a lecture about the church carvings and the very successful Book Fests. Our previous raffle was well supported and this year's has some interesting and special prizes. FoStA also operates a small 'shop', selling cards, notelets, books and pictures, further details of these can be found on the FoStA website [www.fosta.org.uk](http://www.fosta.org.uk)

So how is the money raised used? Clearly the main purpose is to preserve, maintain and improve the fabric of the building and the churchyard. In addition to regular day to day maintenance, work

required may include repairs and renewals identified in surveys and reports. There may also be alterations or improvements identified by the PCC or suggested by other church users. All the above can generally be planned, but there are of course also those unforeseen emergencies which need to be responded to more immediately. FoStA can help with all of these.

These therefore are the 'projects' discussed by the PCC. The Fabric Committee of the PCC will generally obtain quotations or budgets costs for the projects and then, if felt appropriate or necessary, the PCC will ask if FoStA can help fund part or all of the work. Such requests are considered by the FoStA committee before committing to any grant. In making this consideration the committee will always try to help, as this is why people give generously to FoStA and keeping a large balance in the FoStA account does not accord with the main purpose of FoStA and its membership, but at the same time the committee always tries to maintain a reserve in the FoStA account to ensure that they are able to respond to an unexpected emergency should this occur.

In the first seven years after the formation of FoStA, from September 2008 to September 2015, FoStA contributed a total of £23,746.46 towards various projects at St Andrew's Church. Grants ranged from £24 for the construction of portable table tops to go over pews, up to £6766.80 for the removal and replacement of the external lime mortar on the south wall between the tower and the Priest's door. Other projects included the floodlighting of the tower, new energy efficient lighting within the church, tower clock repairs and internal redecoration. Within the churchyard the water supply has been extended and tree surgery carried out. Further details of completed projects funded by FoStA can also be found on the FoStA website.

More extensive repairs of the church building can be well beyond the capacity of the PCC to fund, even with the help of FoStA. Every five years a Quinquennial inspection is carried out by the Diocesan architect and his report advises on what needs to be



undertaken and the urgency of this work. Generally it is expected that all the recommended work is carried out within the following five year period. The deterioration of the Chancel roof was first described in the 2006 Quinquennial report. The 2011 report recommended the complete re-slating of the Chancel roof within the following five years, along with the re-bedding of the ridge tiles to all roofs and the replacing of the guttering to the north elevation. Other recommended work included the re-mortaring of the west wall of the north aisle, internal repair and redecoration of the north, south and west walls and the levelling of an area of the floor at the back of the church.

It was estimated that a total of around £50,000 would be necessary to carry out all these recommendations and thoughts turned to how this money could be raised. One potential source was the Heritage Lottery Fund (HLF) and an application was made by the PCC in July 2014. One of the requirements of the process is that the HLF expects the applicant to make available from their own resources at least 5% of the sum applied for. To meet this requirement FoStA agreed that a sum of £5000 be kept in reserve for this work if required.

Unfortunately the bid to the HLF was unsuccessful. However, an alternative pot of money became available from the government via the Listed Places of Worship (LPoW) Roof Repair Fund. This could only cover the roofing works, but as guttering repairs are considered part of roof repairs, it still amounted to a significant potential source of funds. At the same time additional grant funding offers had been received - £5000 from the Blanchminster Trust and £1000 from the All Churches Trust. In January 2015 the PCC made an application to the LPoW which included £5,000 from FoStA to therefore make £11,000 of joint funding.

In March 2015 the PCC learned that once again their bid had been unsuccessful, although it was recommended that they apply again in the next round of applications in 2016. It was clear that without the grant from the LPoW the work to the Chancel roof and ridge

tiling could not go ahead in 2015 and that a further bid to LPoW should be made for this. However, the £11,000 offers of funding from elsewhere, including the £5000 from FoStA, were still available and could be used to allow the other work, including the guttering, to proceed. The estimated cost for all the other recommended work was £19,000, with £11,000 funding in place. After further consideration by the FoStA committee the offer of an additional grant of £4000 was made, and similarly the Blanchminster Trust increased their funding offer by £4,000. As a result the PCC were able to give the go ahead for the work.

The work to level the floor at the back of church was carried out in April/May 2015, with the repair and replacement of guttering being carried out in Aug/Sep 2015. These works are now complete. The internal decorations were commenced in Oct 2015 with just a small section of lime wash to be completed once the new mortar has thoroughly dried. The external re-mortaring to the west wall is planned for March/April 2016. To date FoStA has provided £4137 towards the completed work, with the remainder of the promised £9000 put aside for the outstanding work.

In the meantime the 2<sup>nd</sup> application to the LPoW Roof Repair Fund was submitted in February 2016. Although it is not a requirement of LPoW that there is joint funding with an application, it was felt that this could be advantageous to the bid, and with this in mind FoStA agreed to allocate a further £5000 as a contribution to the roofing work. A decision is not expected from the LPoW Board of Trustees until June 2016, so even if successful it seems unlikely that the work to the Chancel roof could start before the end of 2016.

So since its inception FoStA has contributed towards projects large and small, many of which could not have gone ahead without this source of funding. The FoStA committee and the PCC of St Andrew's Church are extremely grateful for the unfailing generosity of the FoStA membership which makes this possible.

## **SASTRUGI**

Some FoStA members will recall a rather splendid dinner that was held at the Tree Inn in November 2010 with an after dinner speaker Jonathon Bradshaw. His subject then was walking to the South Pole with an Irish team in November 2007 and he illustrated his fascinating talk with some incredible and amazingly beautiful slides.

He has now written a book entitled SASTRUGI which is the name for parallel wave-like ridges caused by wind on the surface of hard snow, especially in Polar Regions.

The value and interest of the book is in the story of how Jon gave up work with the intention of cycling as much as possible between Europe and North America. He started in England, went across Scotland, around the Faroe Islands and then circumnavigated Iceland. He was warned off trying to cycle across Greenland and the first half of his book describes the task of skiing across Greenland over 31 days from east to west with a diverse group of adventurers. They were led by a guide, and included 2 Belgian snowboarders, 2 Irish men and 1 Irish woman; the Irish folk using the expedition to prepare themselves to walk to the South Pole. His descriptions of the trials and turmoils of this journey are riveting and the second half of the book follows his journey to the South Pole, such that the four of them skied over 58 days to become the first Irish team to successfully complete this near impossible task.

Physical and emotional traumas, written as they occurred in a diary format, are absorbing and despite the repetitive nature of their daily tasks Jon conveys the effect it had on him, at the time and to his attitude to life subsequently, with considerable skill. A fascinating read.

## **A note from our new Webmaster**

Early in February 2016 I assumed the reins as FoStA's new webmaster. Although I am computer literate this is a new area for me and I have much to learn. The original web designer was kind enough to give me a crash course in the basics of Serif Webplus. You can't really learn web design and construction from a book or, indeed, from someone telling you what to do – you simply have to get on and give it a go! Fortunately, the way these things are designed makes it possible to experiment, identify mistakes and learn techniques without actually publishing anything to the *real* web. However you can preview everything in advance of publication (as if it were live) and test the links and graphics to make sure they work.

At first sight not a lot has changed. My aim was threefold – to update, simplify and refresh. With this in mind I worked closely with Val and Ian Barker who provided source material and feedback as each update was completed. A lot of 'deep background' information has been deleted – especially when it was not relevant to FoStA's work and mission. Part of the simplification entailed going back to basics – the website is first and foremost about FoStA – it is not intended to be a proxy website for St Andrew's Church. However, it is only right that visitors should be able to find out easily about our location, services and FoStA-related activities. These all now have prominence in appropriate areas of the site.

Refreshing the site has involved further spring cleaning – decluttering pages, uploading new photographs, which I had taken over the past few months, using a new font throughout and taking away extraneous frames and borders. I hope users will find it clean and fresh – presenting relevant information in a timely and uncluttered way.

Finally, although not visible to users, I have added Google Analytics to all areas of the site. It is important that we know if and when we have visitors, how they used the site and where they came from. This information will be available to the FoStA committee and will help us tailor the site to the needs of visitors. In the first three weeks after initiating Analytics we had 310 page visits by people from the U.K., U.S.A., France and China. I find that very good to know!
